Municipal resolution

- CRP priorities
 - #2
- Question: is WCC an emergency shelter?
 - No and there's confusion
 - Making it a 24 hour shelter means a commitment to personnel, materials, facility upgrades (eg cooling capabilities through heat pump installation), communication to community members
- Motion is passed 6-0 in favor of submitting the resolution to the select board
- Select board preparation
 - Short 5-10 intro to our work and the municipal resolution
 - terry: the board appreciates efficiency, make it clear the work entailed.
 - Items to emphasize:
 - How many hours in WCAT meetings, workshops, preparation
 - Public input on climate action in Wiscasset
 - Important climate indicators last week's coastal storms, 2023 was warmest year on record globally and 2nd warmest for Maine
 - Cost of climate change to town how much more people have to spend
 - More likely to get federal grant funds by making a public commitment
- Projects committee members agreed on this list
 - Prepare the Wiscasset Community Center or a town-owned building as a shelter for climate emergencies
 - considerations: overnight accommodations, food (work with food pantries),

- communications
- Committee members who think this should be #1: Leslie, Cassy, Deb, Terry
- Terry, Cassy, and Leslie volunteer to talk with Rob Bickford (fire chief) and Duane at WCC
- Pleasant Street extension project Leslie is talking with Army Corps of Engineers, DEP, others
 - Shore up Fore Street from erosion
 - Leslie would not prioritize funding from the community action grant for this project
- Municipal efficiency upgrades
 - Johnson Control project they will be presenting different projects and potential costs
 - WCAT could recommend "green"/non-carbon emitting sources of heating and cooling be prioritized (i.e., heat pumps)
- Install public EV charging stations in public parking lots
- Participate in National Flood Insurance Program Community Rating System this gets residents discounts on flood insurance
 - Evan to send Cassy a description of the recommendation
- Wastewater Treatment Plant move this to higher ground out, ideally public works, and apply for the Maine Infrastructure Adaptation Fund to make that move
 - Committee members assented to this project
 - DEP already
- Transition town equipment and vehicles to electric/lower emissions, including electric school buses (e.g., lawn and outdoor equipment, town vehicles, etc.)

Committee members are comfortable with recommending to the economic development director to explore this idea and optimize clean energy generation to increase revenue for Wiscasset, also balancing forest preservation on the whole (i.e., if fewer trees are cut down locating generation closer to transmission on this property, as opposed to developing a clean energy technology park elsewhere, that is supported)
 - ii. Promote Wiscasset as "clean energy friendly" really about endorsing the offshore wind research array, learning more about this and moving towards advocating for Wiscasset to be the connection point for the array's electricity generation
 - 1. Committee members are most comfortable asking the economic development director to invite GEO to present
 - iii. Recommend to the town that it support and explore increasing clean/renewable energy generation, with the town leading by example and encouraging generation in town boundaries. "Prettiest clean energy village in Maine"
 - 1. We recommend that the economic development committee explore and prioritize clean energy/renewable energy development within Wiscasset
 - b. RePower reached out to Governor's Energy Office about their availability for a presentation to WCAT about offshore wind array, would like to invite Select

- Board, Wiscasset Economic Development Director and economic development committee.
- c. RePower WG has talked with organizations like Peregrine Technologies, Chewonki Foundation, Ocean Renewable Power Corporation, and Maine Hydrogen Energy Center - interested in developing renewable energy and storage in a renewable energy park in Wiscasset (e.g., technology park at Mason Station)
 - i. Peter Arnold is talking to the Chamber of Commerce Dec. 21st to talk about directions for renewable energy
